




VIRTUAL EGM REGISTRATION GUIDELINE

The virtual AGM app allows you to access our AGMs/EGMs from anywhere across the globe.



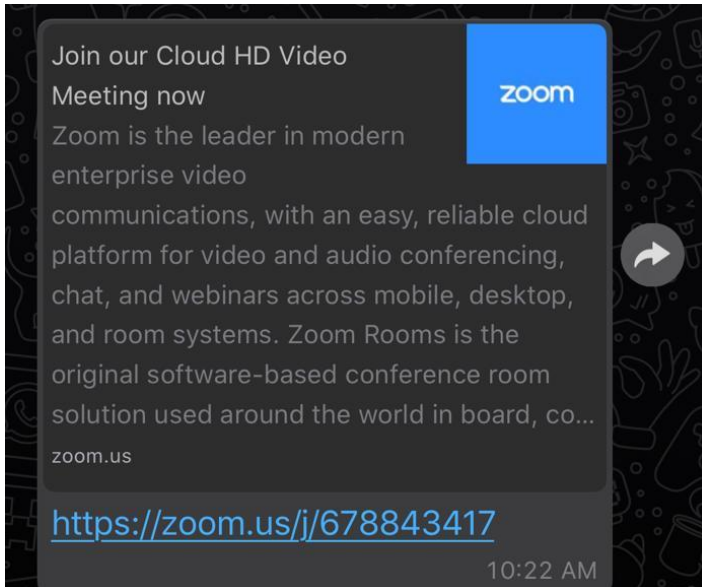

- 2 At 9:00 AM on Wednesday 2 June 2021, please click [here](#) to be redirected to the EGM registration link. You will be asked to provide identification details including your name, proxy (if applicable), phone number, number of shares owned, and investor ID. This step will enable us to verify your identity.

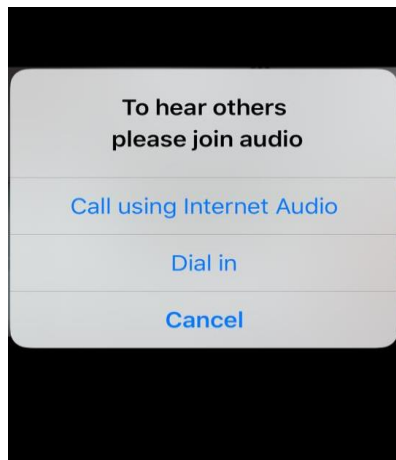
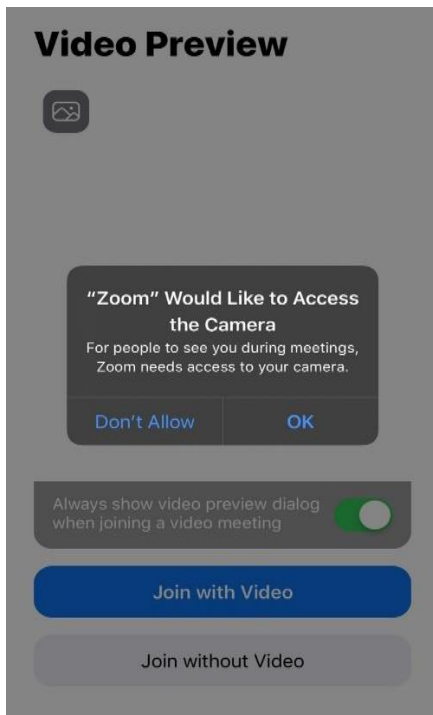


- 3 If your information has been verified, you will receive a link through the app, where a member of Bahrain Clear will register you for the virtual EGM.

EGM registration will be open 24 hours prior to the EGM, and will close on Wednesday 2 June 2021 at 10:45 AM Bahrain time.

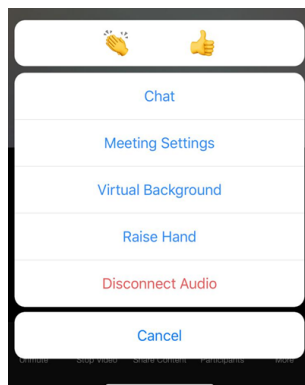

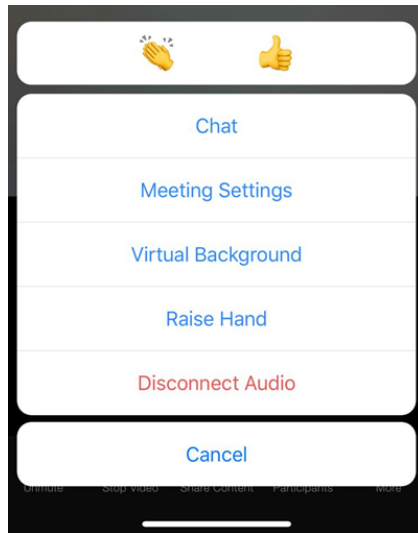
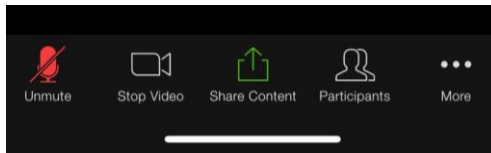
- 5 Please make the microphone and camera accessible, as this will be utilized to verify your identity by Bahrain Clear.

HOW TO ASK A QUESTION DURING THE EGM



- 1 To ask a question during the EGM, tap on the screen, select 'More' and select 'Raise Hand'. The EGM facilitator will request that you unmute your microphone and open the camera to put forward your question.
 - Kindly note that the audience will be able to view and hear all participating attendees.
